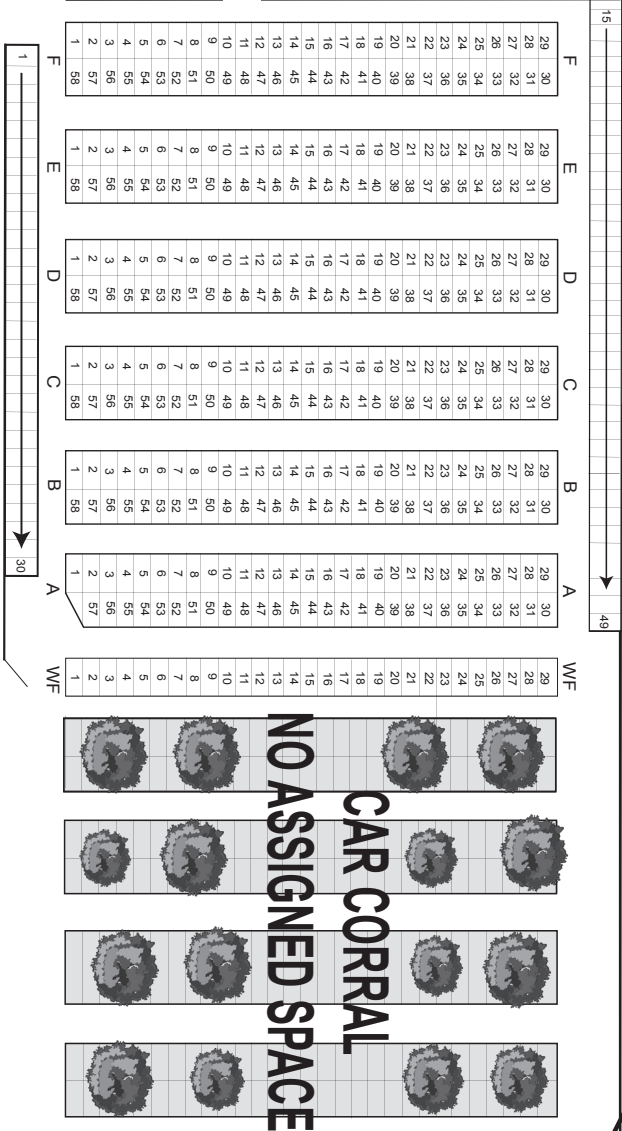

**Seller's Status**

If you do not have a seller's permit and are not an exempt or occasional seller you **MAY NOT** sell at this event.

A temporary permit can be obtained at any local Board of Equalization office, at no cost to you. The business address on your temporary permit should be the address of the temporary selling location. The mailing address is your permanent place of business or residence. Person who exclusively sell exempt property such as fresh produce or cold food products for consumption off the premises are not required to have a seller's permit. Occasional sellers are person who will not be making a series of sales sufficient in number, scope and character to constitute an activity requiring the holding of a seller's permit. Occasional sellers typically include person who have cleared out their garages of their own used items and sell only those items.

- Admission passes and window stickers are intended for the participating vendor only and may not be resold. Any violation of this policy will result in immediate removal from the grounds and relinquishing of space(s).
- No scooters, bicycles, motorcycles or pets allowed.
- No vehicles allowed to drive on swap meet grounds after set up time.
- No breaking down of spaces until 3pm Sunday.
- No parts or other materials are to be left behind or you will be charged for clean-up.
- No food, drinks or controlled substances are to be sold in the swap meet or car corral.**
- All state and local laws apply.**
- Goodguys reserves the right to exclude or reject without recourse any persons or items which have violated these rules or are otherwise deemed objectionable.
